

Dorset & Wiltshire Fire and Rescue Service –

Terms and Conditions for the Wiltshire & Swindon Road Safety Partnership “#seeyouontheroad” competition:

1. Dorset and Wiltshire Fire and Rescue Service (DWFRS) are administering the competition on behalf of Wiltshire & Swindon Road Safety Partnership (WSRSP).
2. Entrants must live, go to school or be home educated within Wiltshire and Swindon.
3. Winners will be selected following the closure of the competition date (as advertised on the website), 23<sup>rd</sup> December 2024.
4. There are three age categories for those who live, or go to school, or are home educated, in Wiltshire and Swindon – One winner will be selected from each of the three age groups.
  - a. Key Stage 2 (years 3-6) in Primary Schools,
  - b. Key Stage 3 (years 7-9) and
  - c. Key Stage 4 (years 10-11) in Secondary Schools.
5. Each group winner will receive a £20 Amazon voucher.
6. The winners associated school will also receive books to the value of £20.
7. The prizes are non-transferable and there is no cash alternative.
8. Only one entry per child is permitted.
9. All entry forms must be emailed to [roadsafety@dwfire.org.uk](mailto:roadsafety@dwfire.org.uk) by midnight on 23<sup>rd</sup> December 2024, including the participant’s name, age and Parent / Carer / school contact details.
10. Entries can be received direct from a pupil’s school email address rather than a personal contact if preferred.
11. Personal data collected will be used to contact the winning entries and will not be shared with any other parties. Details will be securely stored by DWFRS until the winning entries have been contacted and prizes have been transferred, all personal data will then be deleted in line with GDPR regulations.
12. By submitting an entry, the participant agrees that Wiltshire & Swindon Road Safety Partnership may use the competition entry image/animation across their social media channels during the campaign and in future road safety campaigns. In addition, the participant agrees to the image/animation being reproduced, printed and displayed in public places around Wiltshire & Swindon.
13. Parental / Guardian consent will be sought separately should a child’s name, age and school be required for any media coverage e.g. the winners
14. DWFRS are not responsible for entries received after the close of competition date.
15. The WSRSP judges’ decision is final and no correspondence can be entered into.
16. These rules are governed by the laws of England and Wales.
